Calling a Public Hearing on the creation of the Polk County Reinvestment Zone #96-1 for the purpose of commercial/industrial tax abatement

Whereas, the Polk County Commissioners Court desires to promote the development of a certain area within the County's jurisdiction by designating said area as a reinvestment zone, and

Whereas, it has been determined that the proposed zone, located within the boundaries of an area referred to as Lake Livingston Airpark on FM350 S and recorded in Volume 10 Page 1 of the deed records of Polk County, does qualify for designation as a reinvestment zone under Sec 312 202 of the Texas Tax Code Further, it has been determined that the subject area is outside the taxing jurisdiction of an incorporated city or town and that creation of the proposed Reinvestment Zone #96-1 will contribute to the expansion of employment, will attract major investment and will promote economic development in Polk County, and

Whereas, prior to the adoption of an Order designating said Reinvestment Zone #96-1, the County must hold a public hearing to provide interested persons the opportunity to present evidence for or against the designation of said Reinvestment Zone

Now, Therefore, be it Resolved by the Commissioners Court of Polk County, Texas, that a Public Hearing shall be held at 9 30 a.m. on Monday, February 26, 1996 in the Commissioners Courtroom, third floor of the Polk County Courthouse, Livingston, Texas, at which time any interested person may appear and speak for or against the creation of the proposed Polk County Reinvestment Zone #96-1, the area to be included in the proposed Reinvestment Zone and the offering of tax abatement and/or other economic incentives, if any, within the boundaries of the proposed Reinvestment Zone
