Heavy amounts of rainfall occurring throughout the day and into the night of April 3, 1999 created severe flooding in rivers, creeks, city streets and low-lying areas of the county has created an emergency situation for residents. Therefore, County Judge John Thompson has issued an Emergency Declaration for Polk County, as of 4 00 pm on Saturday, April 3, 1999. A voluntary evacuation of low-lying areas has been recommended by the Office of Polk County Emergency Management.

Therefore, effective April 3, 1999 at 4 00 p m ,John P Thompson, County Judge of Polk County, declared a state of emergency within Polk County, Texas
