Last year, the POLK COUNTY property tax rate was \$0.5550. ~~that~~ that rate raised \$9,889,492, a portion of which was used to fund operations such as: Road & Bridge, Sheriffs Department, Building Maintenance, Jury Service, Voter Registration, Data Processing, Etc.

This year, POLK COUNTY is proposing a property tax rate of \$0. ~~6377~~ ⁶²⁷⁷. That rate would raise \$10,505,606, which is \$ 616,114 more than taxes imposed last year.

There will be two public hearings to consider that increase. The first public hearing will be held on September 16, 2005 at 2:00 PM ~~at~~ Polk County Commissioners Courtroom. The second hearing will be held on September 20, 2005 at 4:00 PM at Polk County Commissioners Courtroom.
