### **EMERGENCY (MANDATORY) EVACUATION ORDER**

WHEREAS, by declaration issued September 21, 2005, the County Judge declared a state of disaster for Polk County resulting from Hurricane Rita; and

WHEREAS, said state of disaster requires that certain emergency measures be taken pursuant to the Executive Order of the Governor Relating to Emergency Management; now, therefore, the following regulations shall take effect immediately upon issuance, and shall remain in effect until the state of disaster is terminated: and

WHEREAS, the Polk County Judge John P. Thompson, in his capacity as Emergency Management Director for Polk County has deemed it necessary for public health and safety throughout the duration of Hurricane Rita to issue the following emergency orders;

- 1 MOVEMENT OF PEOPLE AND OCCUPANCY OF PREMISES
  - (a) A person shall not remain or travel upon any public or private property in the following area(s):

Mobile Homes; travel trailers, Low-lying / Flood prone areas; sub-standard housing in Polk County, Texas.

(b) Subsection (a) shall not apply to a person authorized by local government officials to assist in the protection of the health, safety, or welfare of the public.

2.

- (a) These regulations shall have the effect of ordinances when issued by the County Judge at 9:00 a.m. on September 22, 2005.
- (b) A person who violates any provision of these regulations, upon conviction, is punishable of a Class C Misdemeanor by a fine of not more than one thousand dollars (\$1,000.00) and/or six (6) months in iail.

This order shall take effect immediately from and after its passage and publication, and it is accordingly so ordained.
