- 1. WELCOME & CALLED TO ORDER BY JUDGE JOHN P.THOMPSON AT 10:00 A.M.
 - INVOCATION GIVEN BY ELDRIDGE STRIEDEL.
 - PLEDGES TO THE U.S. AND TEXAS FLAGS WERE LED BY KENNETH HAMBRICK.

2. PUBLIC COMMENTS:

- A. LEE HON, DISTRICT ATTORNEY FOR POLK COUNTY, SPOKE IN FAVOR OF BUILDING A **JUDICIAL CENTER ON BLOCK 17 (FORMER PEDIGO BLK) WHICH THE COUNTY PURCHASED ABOUT (4) YEARS AGO. HE CITED OVERCROWDING AND SECURITY ISSUES ARISING FROM AN INCIDENT IN WHICH SHERRY SPRAYBERRY WAS ASSAULTED. HE STRESSED HOW MUCH WE HAVE NEEDED THE BUILDING IN PREVIOUS YEARS.
- B. BILLY HEATH, A CITIZEN WANTS COMMISSIONER WILLIS PCT #1, TO RETURN HIS MANY TELEPHONE CALLS. HE LIVES ON TREE MONKEY ROAD IN ACE. HE WANTS TO DISCUSS WAYS TO ADDRESS AND REPAIR HIS ROAD ISSUES.
- C. DARRELL LONGINO, JP #1, GAVE HIS SUPPORT IN FAVOR OF BUILDING A JUDICIAL CENTER. HE ASKED THAT COMMISSIONERS PLEASE VOTE IN FAVOR OF THE PLAN.
- D. KENNETH HAMMACK, SHERIFF VOICED HIS SUPPORT IN FAVOR OF BUILDING A JUDICIAL CENTER. HE CITED THE NEED FOR MORE SECURITY IN THE COURTHOUSE WHEN INMATES ARE BROUGHT FROM THE JAIL FOR COURT PROCEEDINGS.
- E. JAKE SHERMAN, CO-CHAIR OF THE FACILITIES COMMITTEE THAT HAS COMPLETED 1 1/2 YEARS OF STUDY & PLANNING FOR THE NEW JUDICIAL CENTER, VOICED HIS RECOMMENDATION OF MOVING FORWARD WITH THE PLANS FOR FUNDING & BUILDING A NEW JUDICIAL CENTER ON THE FORMER PEDIGO PROPERTY.
