### **Elected Officials:**

receive regular pay

## Regular Full-Time Employees (including Department Heads)

Who receive benefits (insurance and paid holidays):

received regular pay for payroll ending Sunday, August 31, 2008 (issued today); will receive regular pay for payroll ending September 14, 2008 (to be issued 9/19/08 and to include paid Holiday on 9/1/08);

receive 1.5 times regular rate of pay for all hours recorded during disaster event.

## Part-Time, Labor Pool and Temporary Employees:

Who do not receive benefits:

will receive 2.5 times regular rate of pay for all hours recorded during disaster event.
