
ORDER RESCINDING PROHIBITION OF OUTDOOR BURNING

WHEREAS, the Commissioners Court Polk County, Texas issued an Order Prohibiting Outdoor Burning in the unincorporated areas of the County on June 23, 2009; and


WHEREAS, in an Emergency Session properly posted and held this date, July 31, 2009, the Commissioners Court finds that the public safety hazard that would be exacerbated by outdoor burning has been relieved due to rainfall received over the past week;

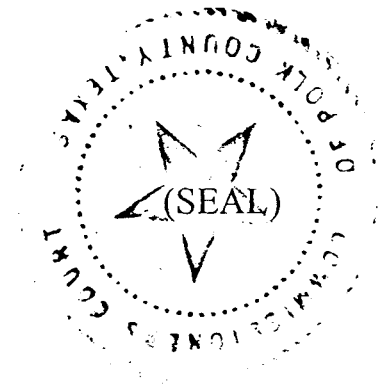
