AGREEMENT FOR OCCUPANCY OF COUNTY-OWNED STRUCTURE

THIS AGREEMENT is entered into on this ____ day of ______, 20___, by and between the Polk County Sheriff's Office, and CHILDRENZ HAVEN, a non-profit advocacy group, and is authorized by the laws of the State of Texas.

I. PURPOSE:

This agreement is entered into for the purpose of providing, for a definite term, certain real property which is owned by the County of Polk, and under the direct control of the Polk County Sheriff's Office hereinafter the GRANTOR, to CHILDRENZ HAVEN, acting by and through its duly authorized representative, hereinafter the GRANTEE.

The real property to be provided ("premises") is known by the flowing physical address/property description: 443 Huckle berry Road, Onglaska 7x, 77360

GRANTOR hereby grants to GRANTEE the right to occupy and use the above-described premises from which to conduct the day-to-day operation of GRANTEE's organization in Polk County, Texas, under the terms and conditions set forth hereunder.

Further, GRANTEE hereby covenants and agrees that the premises shall be used solely for the purpose of the conducting the day-to-day business of GRANTEE's organization, and that all other uses are strictly prohibited. Any use of the Premises for any other purpose than that authorized herein shall constitute a material breach of this agreement, and GRANTOR shall have an immediate right to terminate GRANTEE's occupancy. GRANTEE further recognizes that nothing herein shall be construed as transferring ownership in the premises, and that GRANTOR has no intent to transfer ownership of the premises under the terms of this agreement.

II. GENERAL TERMS AND CONDITIONS:

- (a) LENGTH OF AGREEMENT. The term of this agreement shall be for a period of five (5) years commencing on the date the last party hereto executes this agreement, and ending not more than five (5) years from that date, unless sooner terminated as hereinafter provided. This agreement is contingent upon the approval of the Commissioners Court of Polk County, Texas. If Commissioners Court does not approve this agreement, it shall be void and unenforceable.
- (b) RENEWAL OPTION. By mutual agreement between GRANTEE and GRANTOR, this agreement may be renewed up to five (5) times for a period of up to two (2) years each, under the same terms and conditions. GRANTEE shall give GRANTOR written notice of intention to exercise this option at least 180 days prior to expiration of this agreement.
- (c) <u>CONSIDERATION</u>. GRANTOR recognizes the many ways the operation of an organization such as GRANTEE's benefits and assists the citizens of Polk County, and also acknowledges that this agreement is a means by which GRANTEE may continue to operate in Polk County. GRANTEE recognizes that the premises are being offered "rent-free" and hereby agrees to keep the premises in a good, workman-like condition. Each

party hereby recognizes and acknowledges the sufficiency of the consideration each is receiving under the terms of this agreement.

- (d) MAINTENANCE OF PROPERTY. GRANTEE will be responsible for keeping the Premises in good repair and condition during the term of this agreement. If GRANTEE, or its agents, cause damage to said property that goes beyond "normal wear and tear," the occupying entity is responsible to pay for those repairs.
- (e) <u>CONDITION OF PREMISES</u>. GRANTOR warrants that the Premises are not in violation of any city, state or local ordinance or statute or any restriction imposed against the Premises. However, all other warranties of usefulness, fitness for a particular purpose, suitability, or any other warranty, whether express or implied, are hereby disclaimed by GRANTOR.
- (f) <u>FURNISHINGS.</u> GRANTOR hereby covenants and agrees that the GRANTEE may bring on the Premises any and all furniture, fixtures and equipment reasonably necessary for the efficient exercise of GRANTEE's business and the parties agree that all such Property shall remain the Property of the GRANTEE.
- (g) <u>ALTERATIONS AND IMPROVEMENTS.</u> GRANTEE will have authority to make alterations and improvements to the Premises necessary for the its continued effective operation; have er, any and all improvements or alterations made to the Premises shall remain the property of the GRANTOR at the termination of this agreement. GRANTEE hereby agrees to bear all costs and assume all risk associated with said alterations or improvements.
- (h) <u>SIGNAGE</u>. Any signs necessary to indicate the GRANTEE's name, location and governmental purpose shall be prepared and installed consistent with signage for other GRANTEEs in the property and in keeping with building décor. Any special requirements of GRANTEE contrary to the above must be stated in writing and made a part of this lease. Any cost of compliance with this shall be borne by the GRANTEE.
- (i) <u>Property of Grantee</u>. On termination of this lease, by lapse of time or otherwise, the Grantee may, within a reasonable time thereafter, at its option and expense, remove from said Premises any and all equipment, appliances or other personal property placed or owned by it thereon except as provided by subsection (f) hereinabove.
- (j) <u>CONDEMNATION.</u> If during the term of this agreement, said Premises, or any portion thereof, shall be condemned for any public purpose, GRANTEE hereto shall have the option of terminating and canceling the lease upon 30 days notice to the GRANTOR of its election to do so.
- (k) <u>Substantial Property Damage</u>. In the event the building, of which the space occupied by the GRANTEE is a part, suffers substantial damage or is destroyed by fire or the elements during the term of this agreement, the GRANTOR will have the option to rebuild or repair the building in substantially as good a condition as it was before such fire or other event occurred, or to declare the lease contract canceled.
- (l) <u>ABANDONMENT</u>. The GRANTEE will not, without first obtaining the written consent of the GRANTOR, abandon the Premises, or allow the Premises to become vacant or deserted. In the event GRANTEE's need for such space terminates, the GRANTEE will make every attempt to notify the GRANTOR 60 days before vacating the Premises.

- (m) <u>Termination</u>. Except as otherwise provided herein, GRANTEE / GRANTOR shall each have the right to cancel and terminate this agreement at anytime and for any reason whatsoever by giving the other party written notice 60 days prior to the desired cancellation date.

ORDER ADOPTING RULES OF POLK COUNTY, TEXAS FOR ON-SITE SEWAGE FACILITIES PREAMBLE

WHEREAS, the Texas Commission on Environmental Quality (TCEQ) has established Rules for on-site sewage facilities to provide the citizens of this State with adequate public health protection and a minimum of environmental pollution; and

WHEREAS, the Legislature has enacted legislation, codified as Texas Health and Safety Code (THSC), Chapter 366, which authorizes a local government to regulate the use of on-site sewage facilities in its jurisdiction in order to abate or prevent pollution or injury to public health arising out of the use of on-site sewage facilities; and

WHEREAS, due notice was given of a public meeting to determine whether the Commissioners Court of Polk County, Texas should enact an order controlling or prohibiting the installation or use of on-site sewage facilities in the County of Polk, Texas; and

WHEREAS, the Commissioners Court of Polk County, Texas finds that the use of on-site sewage facilities in Polk County, Texas is causing or may cause pollution, and is injuring or may injure the public health; and

WHEREAS, the Commissioners Court of Polk County, Texas has considered the matter and deems it appropriate to enact an Order adopting Rules regulating on-site sewage facilities to abate or prevent pollution, or injury to public health in Polk County, Texas.

NOW, THEREFORE, BE IT ORDERED BY THE COMMISSIONERS COURT OF POLK COUNTY, TEXAS:

- SECTION 1. THAT the matters and facts recited in the preamble hereof are hereby found and determined to be true and correct;
- SECTION 2. THAT the use of on-site sewage facilities in Polk County, Texas is causing or may cause pollution or is injuring or may injure the public health;
- SECTION 3. THAT an Order for Polk County, Texas be adopted entitled "On-Site Sewage Facilities", which shall read as follows:

AN ORDER ENTITLED ON-SITE SEWAGE FACILITIES

SECTION 4. CONFLICTS.

This Order repeals and replaces any other On-site Sewage Facility (OSSF) Order for Polk County.

SECTION 5. CHAPTER 366.

The County of Polk, Texas clearly understands that there are technical criteria, legal requirements, and administrative procedures and duties associated with regulating on-site sewage facilities, and will fully enforce Chapter 366 of the THSC and Chapters 7 and 37 of the Texas Water Code (TWC), and associated rules referenced in Section 8 of this Order.

SECTION 6. AREA OF JURISDICTION.

The Rules shall apply to all the area lying in Polk County, Texas, except for the area regulated under an existing Rule and the areas within incorporated cities.

JECTION 7. ON-SITE SEWAGE FACILITY RULES.

Any permit issued for an on-site sewage facility within the jurisdictional area of Polk County, Texas must comply with the Rules adopted in Section 8 of this Order.

SECTION 8. ON-SITE SEWAGE FACILITY RULES ADOPTED.

The Rules, Title 30 Texas Administrative Code (TAC) Chapter 30, Subchapters A and G, and Chapter 285, promulgated by the TCEQ for on-site sewage facilities are hereby adopted, and all officials and employees of Polk County, Texas having duties under said Rules are authorized to perform such duties as are required of them under said Rules.

SECTION 9. INCORPORATION BY REFERENCE.

The Rules, 30 TAC Chapter 30, Subchapters A and G, and Chapter 285 and all future amendments and revisions thereto are incorporated by reference and are thus made a part of these Rules.

SECTION 10. AMENDMENTS.

The County of Polk, Texas wishing to adopt more stringent Rules for its OSSF Order understands that the more stringent local Rule shall take precedence over the corresponding TCEQ requirement. Listed below are the more stringent Rules adopted by Polk County, Texas:

- (A) All maintenance of an on-site sewage disposal system using aerobic treatment shall be conducted by a TCEQ registered or licensed maintenance company unless:
- 1. The homeowner of his/her primary single family residence is a TCEQ Registered or Licensed Maintenance Provider for their aerobic treatment unit; or
- 2. The homeowner of his/her primary single family residence is trained and certified by an Installer II, Aerobic Manufacturer or the OSSF Designative Representative for the County; or
- 3. The homeowner of his/her primary single family residence is trained by a TCEQ Registered or Licensed Maintenance Provider.
- (B) The required maintenance inspection and test report, conducted by the above described certified homeowner or the TCEQ registered Maintenance Company, which must be arbunitted once every 4 months to the permitting authority, shall:
- 1. Meet all inspection requirements as set by TCEQ Rules, Polk County Policy and Procedural Requirements, as well as, the inspection requirements outlined by the manufacturer for the brand being inspected; and
- 2. Address all testing requirements as set by the TCEQ Rules, Polk County Policy and Procedural Requirements, as well as, the testing requirements outlined by the manufacturer for the brand being inspected; and
- 3. Report the sludge levels in the pump tank, and the condition of the spray area.

SECTION 11. DUTIES AND POWERS.

The OSSF Designated Representative (DR) (30 TAC § 285.2(17)) of Polk County, Texas, must be certified by the TCEQ before assuming the duties and responsibilities.

SECTION 12. COLLECTION OF FEES.

All fees collected for permits and/or inspections shall be made payable to Polk County, Texas. A processing fee of \$15.00 per year for all service policies shall be submitted to the Permitting Office through the Maintenance Company or Technician. A fee of \$10 will also be collected for each on-site sewage facility permit to be paid to the On-Site Wastewater Treatment Research Council as required by the THSC, Chapter 367.

SECTION 13. APPEALS.

Persons aggrieved by an action or decision of the designated representative may appeal such action or decision to the Commissioners Court of Polk County, Texas.

SECTION 14. ENFORCEMENT PLAN

The County of Polk, Texas clearly understands that, at a minimum, it must follow the requirements in 30 TAC § 285.71 Authorized Agent Enforcement of OSSFs.

This Order adopts and incorporates all applicable provisions related to on-site sewage facilities, which includes, but is not limited to, those found in Chapters 341 and 366 of the THSC, Chapters 7, 26, and 37 of the TWC and 30 TAC Chapter 30, Subchapters A and G, and Chapter 285.

SECTION 15. SEVERABILITY

It is hereby declared to be the intention of the Commissioners Court of Polk County, Texas, that the phrases, clauses, sentences, paragraphs, and sections of this Order are severable, and if any phrase, clause, sentence, paragraph, or section of this Order should be declared unconstitutional by the valid judgment or decree of any court of competent jurisdiction, such unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, paragraphs, or sections of this Order, since the same would have been enacted by the Commissioners Court without incorporation in this Order of such unconstitutional phrases, clauses, sentences, paragraphs, or sections.

SECTION 16. RELINQUISHMENT OF ORDER

If the Commissioners Court of Polk County, Texas decides that it no longer wishes to regulate on-site sewage facilities in its area of jurisdiction, the Commissioners Court, as the authorized agent, and the TCEQ shall follow the procedures outlined in 30 TAC § 285.10 (d) (1) through (4).

After relinquishing its OSSF authority, the authorized agent understands that it may be subject to charge-back fees in accordance with 30 TAC § 285.10 (d) (5) and §285.14 after the date that delegation has been relinquished.

INTERLOCAL AGREEMENT BETWEEN POLK COUNTY, TEXAS AND THE CITY OF CORRIGAN FOR USE OF WATER TOWER

This Interlocal Agreement ("Agreement") is made by and between Polk County, Texas, a political subdivision of the State of Texas ("the County"), acting by and through its duly elected Commissioners Court, for the benefit of the Polk County Sheriff's Office, and the City of Corrigan, Texas ("the City"), a general law (Type A) municipality and political subdivision of the State of Texas, acting by and through its duly authorized representative (known collectively as "the parties").

WITNESSETH:

WHEREAS, The Interlocal Cooperation Act, Texas Government Code Section 791 et seq authorizes local governments of the State of Texas to enter into contracts for performance of governmental functions and services in order to increase their efficiency and effectiveness; and

WHEREAS, the County and the City are local governments as defined in the Texas Government Code, Section 791.003(4), and have the authority to enter into this agreement, and have each entered into this agreement by the action of its governing body in the appropriate manner prescribed by law; and

WHEREAS, a consolidated effort between the County and City that would improve communication between law enforcement officers that serve both jurisdictions would increase the effective and efficient functioning of each party; and

WHEREAS, the County owns communications equipment which operates most effectively when placed at a great height, and the City owns a water tower of a sufficient height to allow effective operation of the County's communications equipment, and both parties would be benefited by the increased effectiveness of communication between law enforcement and emergency personnel such equipment would provide;

NOW, THEREFORE, the County and the City agree as follows:

I. OBLIGATIONS OF THE COUNTY

- A. The County is responsible for installing communications equipment atop the city-owned water tower located at 203 North Collins Street, Corrigan, Texas, and in the City of Corrigan Police Department located at that same address. All City of Corrigan permits are waived for this project, if any should be necessary at all.
- B. The County will provide the personnel, equipment, tools and the like necessary to install and maintain the communications equipment contemplated by subsection (I)(A) above, and shall attempt to keep disruption of the day-to-day business of the City and its employees to a minimum.
- C. The County shall, to the extent authorized under the Constitution and laws of the State of Texas, hold the City harmless from liability resulting from the negligent acts or omissions of the

County, its officers, agents and employees pertaining to the activities to be carried out pursuant to the obligations of this agreement; provided, however, the County shall not hold the City harmless from any claims, demands, or causes of action arising in favor of any person or entity, growing out of or incident to, or resulting directly or indirectly from negligence (whether sole, joint, concurring or otherwise) of the City, its officers, agents, representatives, or employees, or any person or entity not subject to the County's supervision or control.

U. OBLIGATIONS OF THE CITY

- A. The City agrees to allow the County's equipment and personnel access to the City-owned property including, but not limited to, the property at 203 North Collins Street, Corrigan, Texas, for the purpose of installing and maintaining the communications equipment contemplated by this agreement.
- B. The City shall, to the extent authorized under the constitution and laws of the State of Texas, hold the County, their officers, agents and employees harmless from any liability, loss or damage they may suffer as a result of claims, demands, costs or judgments against them arising out of the activities to be carried out pursuant to the obligations of this agreement, including but not limited to the use by the City of the results obtained from the activities performed by the County under this Agreement; provided, however, the City shall not hold the County harmless from any claims, demands, or causes of action arising in favor of any person or entity, growing out of, or incident to, or resulting directly or indirectly from the negligence (whether sole, joint, concurring or otherwise) of the County, its officers, agents, representatives, or employees, or any person or entity not subject to the City's supervision or control.

III. TERM, TERMINATION

- A. This Agreement shall be effective on the date of execution by all parties, and shall continue from month to month until terminated as provided herein. This agreement is non-renewable and non-assignable.
- B. If either party hereto desires to terminate this agreement, the party desiring termination shall request such termination in writing, sent by certified mail, return receipt requested to the other party. Upon receiving the request for termination, the County shall have thirty (30) days from its receipt to remove any County-owned equipment that was installed or maintained pursuant to this agreement from the City-owned property, and this agreement shall terminate at the end of said thirty (30) day period.

IV. MISCELLANEOUS

A. <u>Severability</u>. If any section, subsection, sentence, clause, or phrase of this agreement is for any reason held to be unconstitutional, void, or invalid, the validity of the remaining portions of the agreement shall not be affected thereby. It is the intent of the parties signing this agreement that no portion of it, or provision or regulations contained in it shall become inoperative or fail by

reason of unconstitutionality or invalidity of any other section, subsection, sentence, clause, phrase, provision, or regulation of this agreement.

- B. <u>Law and Venue</u>. This Agreement shall be governed by the laws of the State of Texas. The obligations under this Agreement are performable in Polk County, Texas. It is expressly understood that any lawsuit or litigation arising out of or relating to this agreement will take place in Polk County, Texas.
- C. <u>Alteration, Amendment, or Modification</u>. This agreement may not be altered, amended, or modified except in writing, approved by the County Judge of Polk County and the duly authorized representative of the City of Corrigan.
- D. <u>Notice</u>. The address of City for all purposes shall be:

- E. <u>Independent Relationship</u>. Both parties hereto, in the performance of this agreement, shall act in an individual capacity and not as agents, employees, partners, joint ventures or associates of one another. The employees or agents of one party shall not be deemed or construed to be the employees or agents of the other party for any purposes whatsoever.
- F. <u>No Waiver of Immunities.</u> Nothing in this agreement shall be deemed to waive, modify or amend any legal defense available at law or in equity to the parties hereto, their past or present officers, employees, or agents or employees, nor to create any legal rights or claim on behalf of any third party. Neither party waives, modifies, or alters to any extent whatsoever the availability of the defense of governmental immunity under the laws of the State of Texas and of the United States.
- G. <u>Compliance with Laws.</u> The parties hereto shall comply with all federal, state, and local laws, statutes, ordinances, rules and regulations, and the orders and decrees of any courts or administrative bodies or tribunals in any matter affecting the performance of this Agreement, including, without limitation, Worker's Compensation laws, minimum and maximum salary and wage statutes and regulations, licensing laws and regulations.
- H. <u>Entire Agreement.</u> This agreement constitutes the entire agreement between the parties hereto, and supersedes all their oral and written negotiations, agreements, and understandings of every

kind. The parties hereto understand, agree, and declare that no promise, warranty, statement, or representation of any kind whatsoever, which is not expressly stated in this agreement, has been made by any party hereto or its officer, employees, or other agents to induce execution of this Agreement.

I. <u>Disclaimer of Warranty.</u> The County hereby expressly disclaims any warranty of suitability, fitness for a particular purpose or any other warranty, whether express or implied, related to the quality and suitability of its performance, personnel, equipments, results, or the like.
