JUDGE THOMPSON ASKED COMMISSIONERS TO MAKE A MOTION TO SIGN ON OR NOT.

6. MOTIONED BY BOB WILLIS, SECONDED BY RONNIE VINCENT TO APAPROVE POLK COUNTY PARTICIPATION IN THE REGIONAL PUBLIC DEFENDER PROGRAM.

DISCUSSION ON ITEM 7 REGARDING THE FLOORING AT THE LAW ENFORCEMENT CENTER. BOB KINGHAM, TIM WIMBERLEY AND SHERIFF HAMMACK WERE PRESENT. SHERIFF HAMMACK PRESENTED HIS DOCUMENTATION ON RESOLVING THE FLOOR ISSUE. THE MONDO FLOORING IS COMING UP BECAUSE THE ADHESIVE IS NOT HOLDING. BOB KINGHAM STATED THERE HAD BEEN MOISTURE TESTS DONE AND THEY CAME BACK POSITIVE. J.E. KINGHAM OFFERED TO REPLACE FLOORING IF AN AGREEMENT CAN BE MADE ON WHAT TO REPLACE. A DISCUSSION WAS HELD ON WHAT FLOORS NEEDED TO BE REPLACED AND WHAT TYPE OF FLOORING WOULD BE USED FOR REPLACEMENT. JUDGE THOMPSON ASKED THE COMMISSIONERS TO TABLE THIS ISSUE FOR FURTHER DISCUSSION.
