PETITION FOR THE RELEASE OF PUBLIC SCHOOL FUNDS FROM THE POLK COUNTY PERMANENT SCHOOL FUND

WHEREAS, the Public Schools of Polk County currently own a real property in Throckmorton County, Texas, by virtue of a land grant issued by the State of Texas; and

WHEREAS, the Commissioners' Court of Polk County is the legal trustee of such real property and any monies it may generate; and

WHEREAS, the afore mentioned real property has generated a mineral bonus payment in the amount of \$2,396,940.80; and

WHEREAS, the funds are being held in trust within the Polk County Permanent School Fund; and

WHEREAS, the current crisis in public school funding necessitates the use of all available school revenue sources for the education of children within Polk County;

NOW, THEREFORE, BE IT RESOLVED, that the Corrigan-Camden Independent School District Board of Trustees petitions the Polk County Commissioners' Court for a disbursement of its proportional share of the \$2,396,940.80 mineral bonus payment from the Polk County Permanent School Fund in the amount of \$338,465.31; and

BE IT FURTHER RESOLVED, that this disbursement of funds from the Polk County Permanent School Fund shall be utilized for payment of existing debt due to renovation and or repairs, of the existing school facilities as well as new necessary upgrades to include:

*\$134,747.20 - Upgrade of Technology Infrastructure for Corrigan-Camden Independent School District. ComputerLand has provided a bid for this amount which covers the following aspects of repairing/upgrading a "core infrastructure that is near failure." 1) Replace all servers with new servers making access faster and safer, 2) Replace core switching (first step required for any work), 3) Firewall to entire school for content filtering and security, 4) New foundation wiring and fiber for basis of enhanced network (will upgrade connection between servers and closets and provide access to computers), 5) Provide for core wireless with ten(10) access points at key locations, and 6) ALL OF THIS IS TO REPLACE EQUIPMENT PAST ITS SERVICE LIFE AND COULD FAIL AT ANY TIME.
