



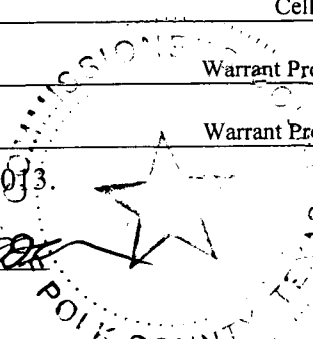
**(REVISED) ORDER
