## Designating Surplus/Salvage Property to be Donated to Volunteer Fire Departments of Polk County

WHEREAS, in a regular meeting of the Polk County Commissioners Court held July 8, 2014, certain items as listed on "Exhibit A" consisting of (2) pages, were determined to be surplus property as defined by Local Government Code, Chapter 263 Subchapter D, Section 263.151, consisting of

# Sheriff's Department Radios, light bars and assorted equipment as listed on Exhibit "A" attached hereto.

**FURTHERMORE,** pursuant to Local Government Code, Section 263.152(a)(4), The commissioners court may dispose of surplus property by donating it to a civic or charitable organization located in the county if the commissioners court determines that: (A) undertaking to sell the property would likely result in no bids or a bid price that is less than the county's expenses required for the bid process; (B) the donation serves a public purpose; and (C) the organization will provide the county with adequate consideration;

**THEREFORE BE IT ORDERED**, that the Commissioners Court approves the donation of the property listed on Exhibit A attached hereto to the (requesting) Volunteer Fire Departments providing fire protection services within the County, having found that such action meets the criteria of and is in compliance with Local Government Code.
