Request is hereby respectfully made by NICHOLSON SERVICES, INC., on behalf of Breckenridge Exploration Co, Inc., NewPek hereinafter referred to as "BECI", to conduct a 3-D seismic survey over and across the following described lands located in Baylor, Throckmorton, or Young County, TX to wit: *per the attached documentation, to-wit:*

In consideration for granting this permission, BECI's operations will be conducted in accordance with good standard practices and in a prudent and careful manner, and we agree to hold you free and harmless from any and all claims for damages that may result from BECI's operations on your lands. It is the intent of this permit to cover all surface or mineral interests owned or leased by you within the boundaries of the 3D seismic survey including those interests that may not have been identified at the time of execution of this permit.

Compensation: Total Net Acres: 1,098.00 PER ACRE: \$5.00 Total Check: \$5,490.00

The following conditions shall be complied with while conducting seismic operations on your property.

- No vehicles shall be driven on said property when the ground is wet or muddy without permission.
- No fences shall be cut or dropped, unless authorized by the landowner and/or tenant. All fences and gates shall remain as found.
- BECI will observe and abide by all applicable IAGC safety and environmental guidelines, explosive offset limits, vibroseis offset limits, as set out in the Energy Source Operation Distance Chart commonly used by the geophysical industry (IAGC Revised May 22, 1998). Any deviation from these limits will be monitored for safety by a qualified vibration monitoring contractor.
- All trash, flagging materials and other equipment used in the geophysical survey shall be removed upon completion of the seismic survey.
- Dozing authorized as necessary.

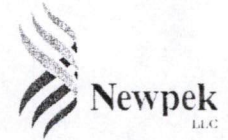

Dear Mr. Jones:

NewPek is exercising the option to explore our mineral interest beneath Polk County School Lands, as described in the lease recorded in Volume 400, Page 388 of the deed records of Throckmorton County, Texas and in Volume 337, Page 14 of the deed records of Baylor County, Texas. At NewPek LLC's direction, Breckenridge Geophysical Company will be conducting a seismic survey across properties located in Throckmorton County, Texas during the months of July, August and September. In preparation for the upcoming project, Breckenridge has contracted with Nicholson Land Services to notify property owners within the confines of the project boundary that this undertaking is occurring.

The physical presence of geophysical recording equipment (E/W blue circles on the diagram) on Polk County property (red hatched area on diagram) will be for a duration of approximately two weeks, commencing in August. Vibrosies source equipment will travel along the lines (N/S yellow stars on the diagram), stopping every 165' for a 3 second period. Prior to positioning the geophysical equipment, surveyors will access the property to place location flags and a bull dozer will clear debris from the source lines, as necessary.

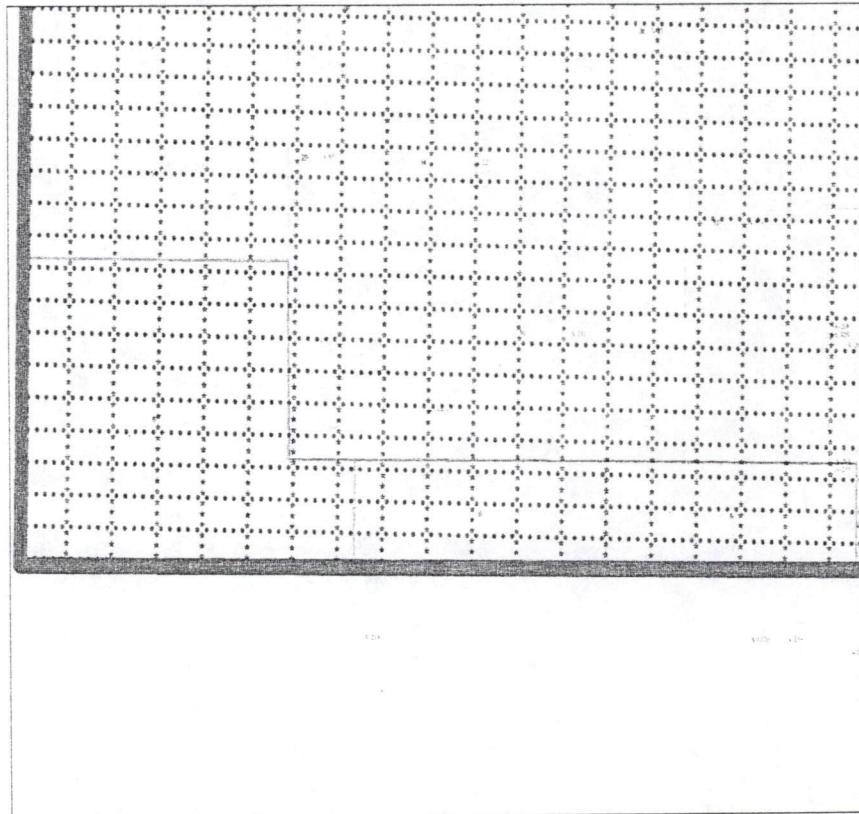
