is hereby given that two Special meetings of the Polk County Commissioners Court will be held in the Commissioners Courtroom, 3rd flr, Polk County Courthouse, Livingston, Texas on the dates stated herein, at which time the following subject/s will be discussed;

PUBLIC HEARINGS ON PROPOSED 2014 TAX RATE

A tax rate of \$0.6461 per \$100 valuation has been proposed for adoption by the governing body of POLK COUNTY. This rate exceeds the lower of the effective or rollback tax rate, and state law requires that two public hearings be held by the governing body before adopting the proposed tax rate.

PROPOSED TAX RATE	\$0.6461 per \$100
PRECEDING YEAR'S TAX RATE	\$0.6461 per \$100
EFFECTIVE TAX RATE	\$0.6355 per \$100
ROLLBACK TAX RATE	\$0.6979 per \$ 100

The effective tax rate is the total tax rate needed to raise the same amount of property tax revenue for POLK COUNTY from the same properties in both the 2013 tax year and the 2014 tax year.

The rollback tax rate is the highest tax rate that POLK COUNTY may adopt before voters are entitled to petition for an election to limit the rate that may be approved to the rollback rate.

YOUR TAXES OWED UNDER ANY OF THE ABOVE RATES CAN BE CALCULATED AS FOLLOWS: property tax amounts (rate) x (taxable value of your property)/100
