ORDER EXEMPTING PRECINCT 2 PURCHASE OF  
VOLVO EW180D WHEELED EXCAVATOR  
FROM REQUIREMENTS OF THE COUNTY PURCHASING ACT

WHEREAS, the Commissioners Court of Polk County, Texas desires to purchase one (1) Volvo EX180D Wheeled Excavator from ROMCO Equipment Co. through the Houston-Galveston Area Council (HGAC) cooperative purchasing program and in authorizing this purchase the Polk County Commissioners Court desires to grant an exemption for this purchase from the requirements of the County Purchasing Act in accordance with Texas Local Government Code Section 271.102(a)(b)(c), which states that a local government may participate in a cooperative purchasing program with another local government or a local cooperative organization (and that) a local government that purchases goods or services under this subchapter satisfies any state law requiring the local government to seek competitive bids for the purchase of the goods or services, as an item that can be obtained from only one source.


WHEREAS, the Commissioners Court of Polk County finds that this purchase qualifies for an exemption under the provisions of Section 271.102(a)(b)(c) of the Texas Local Government Code and that granting an exemption to the purchasing requirements of the County Purchasing Act is warranted in this case.

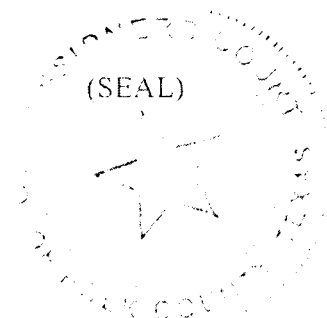
