"Tommy" Overstreet - Commissioner Pct #4, Schelana Hock - County Clerk And Margie Ainsworth - County Auditor. The following agenda items, orders and decrees were duly made, considered & passed.

- 1. WELCOMED & CALLED TO ORDER AT 10:00 A.M. BY JUDGE MURPHY.
 - INVOCATION LED BY WAYNE BICKLEY OF SODA BAPTIST CHURCH.
 - PLEDGE OF ALLEGIANCE TO U.S. & TX FLAGS LED BY JIM JOHNSON.

2. PUBLIC COMMENTS:

JAMES VANDEVENDER ASKED THE COURT TO CONSIDER NAMING THE GAZEBO AFTER HIS FATHER IN LAW WILLIAM VANCONGER IN MEMORY OR HONOR OF HIM. JAMES SAID HIS FATHER IN LAW BUILT GAZEBO AND DID A LOT FOR THE COMMUNITY.

3. INFORMATIONAL REPORTS:

JUDGE MURPHY UPDATED COURT REGARDING THE SUDDEN CLOSURE OF WALMART ON MONDAY, APRIL 13 DUE TO WHAT THE COMPANY STATED WERE "EXTENSIVE PLUMBING ISSUES" REQUIRING THE STORE TO BE CLOSED FOR 3-6 MONTHS. SHE NOTED THAT THE SAME REASON WAS GIVEN FOR EACH OF THE 5 STORES THAT WERE CLOSED ACROSS THE COUNTRY ON THE SAME DATE. JUDGE MURPHY SAID HER OFFICE HAS BEEN IN CONTACT WITH THE STATE COMPTROLLER TO GET FIGURES ON POTENTIAL LOSS OF COUNTY SALES TAX REVENUE. A QUESTION & ANSWER SESSION WILL BE HELD FRIDAY AT CHO-YEH FOR WALMART ASSOCIATES(ONLY). JUDGE MURPHY HAS ALSO VISITED WITH REPRESENTATIVE JAMES WHITE REGARDING THE IMPACT TO THIS AREA OF THE STORE CLOSURE — THE LARGEST BEING THAT 420+ PEOPLE ARE NOW WITHOUT JOBS, ALTHOUGH SOME ARE

SUPPOSEDLY GOING TO RECEIVE 60 DAY SEVERANCE PACKAGES. JUDGE MURPHY ALSO STATED A MAIN CONCERN IS THE PHARMACY AND EFFECT IT WILL HAVE ON VETERANS, THE INDIGENT & ELDERLY WHO DEPEND HEAVILY ON THE PHARMACY AND ASKED. REPRESENTATIVE WHITE TO VISIT WITH WALMART ABOUT OTHER POSSIBILITIES IN REGARD TO PHARMACY SERVICES.

JUDGE MURPHY ALSO NOTED THE NEED TO SERIOUSLY ADDRESS BUDGETARY CONTROLS.

JUDGE MURPHY ALSO UPDATED COURT ABOUT DEPARTMENTS RELOCATING TO THE COURTHOUSE, NOTING THAT THE TEXAS RANGER & PERMITS DEPARTMENT WILL BE MOVING INTO OFFICE SPACE ON THE FIRST FLOOR ACROSS FROM ENVIRONMENTAL ENFORCEMENT OFFICER AND ALL WILL SHARE A SECRETARY.

JUDGE MURPHY CALLED FOR ANY OTHER INFORMATIONAL REPORTS FROM OFFICIALS OR DEPARTMENT HEADS - THERE WERE NONE.

JUDGE MURPHY NOTED ADDITIONAL INFORMATION PROVIDED IN HANDOUTS TO MEMBERS OF THE COURT, INCLUDING ITEM A.
