MOTIONED BY TOMMY OVERSTREET, SECONDED BY MILTON PURVIS, APPROVAL TO ACCEPT PROPOSAL FROM CLAY JONES, A CONTACT ELECTRIC RENTALS, TO TRADE (2) PREVIOUSLY DESIGNATED SURPLUS GENERATORS FOR (2) NEW GENERATORS TO BE INSTALLED AT MAINTENANCE FUEL PUMPS AND CORRIGAN SUB-COURTHOUSE WITH ESTIMATED INSTALLATION COST OF \$2,500 TO BE PAID FROM CURRENTLY BUDGETED MAINTENANCE DEPARTMENT FUNDS, THEREBY REVISING COURT ACTION TAKEN ON JANUARY 14, 2015. ALL VOTING YES.

13. BUDGET WORKSHOP: (DISCUSSION OF A-E)

- A. MOTIONED BY MILTON PURVIS, SECONDED BY RONNIE VINCENT, TO RECEIVE 2015 EFFECTIVE TAX RATE CALCULATION OF \$0.6417 FROM TAX ASSESSOR-COLLECTOR AND ANTICIPATED COLLECTION RATE OF 96%.

- B. MOTIONED BY TOMMY OVERSTREET, SECONDED BY RONNIE VINCENT, TO PROPOSE NO INCREASES IN SALARIES, EXPENSES AND ALLOWANCES OF COUNTY & PRECINCT ELECTED OFFICIALS FOR FY2016 OTHER THAN LONGEVITY.
- C. JUDGE MURPHY REVIEWED THE COURT'S CONSENSUS FROM THE AUGUST 6, 2015 BUDGET WORKSHOP. TO PROPOSED A BUDGET BASED ON THE SAME TOTAL RATE AS LAST YEAR - 0.6461 - WITH THE DEBT PORTION OF THE RATE TO BE 0.1234, THE ROAD & BRIDGE PORTION 0.1429 AND THE GENERAL FUND PORTION 0.3798. COMMISSIONER OVERSTREET QUESTION WHETHER COMMISSIONER PURVIS, WHO WAS NOT ABLE TO ATTEND THE 8/6/15 WORKSHOP. WAS AGREEABLE TO EACH PRECINCT FUNDING AND EQUAL PORTION OF THE \$25,208 DIFFERENCE IN FUNDING FOR A FULL TIME SECRETARY I POSITION IN THE EXTENSION OFFICE RATHER THAN REDUCING THE POSITION TO A PART TIME RECEPTIONIST. COMMISSIONER PURVIS INDICATED THAT HE WAS AGREEABLE. JUDGE MURPHY DETAILED OTHER MINOR CHANGES THAT HAD OCCURRED IN THE DRAFT BUDGET SINCE THE AUGUST 6TH MEETING, NOTING THAT CONTINUED MONITORING WAS NECESSARY FOR A POSSIBLE REDUCTION IN THE PROPOSED IAH INMATE PHONE REVENUE. MOTIONED BY MILTON PURVIS. SECONDED BY RONNIE VINCENT, TO TAKE RECORD VOTE TO PLACE A PROPOSAL TO ADOPT A SPECIFIED RATE OF \$0.6461 ON AGENDA OF THE MEETING SCHEDULED FOR SEPTEMBER 8, 2015 AT 10 A.M.

ALL VOTING YES.

DISCUSSION OF SHERIFF'S DEPT BUDGET, WITH THE COURT NOTING THAT A \$53,164.51 (1.46%) REDUCTION WOULD BE REQUIRED AND THAT IT WOULD BE UP TO THE SHERIFF AS TO WHERE THE REDUCTION WAS MADE. SHERIFF INITIALLY REQUESTED THAT THE WAGE & BENEFIT LINE ITEM AMOUNT BE REDUCED, WITHOUT DELETING A (VACANT) POSITION, IN ANTICIPATION THAT THE FUNDS WOULD BE REMAINING UNUSED AT FY2016 YEAR END. THE

COURT NOTED THAT THE BUDGET HAD TO BE BASED ON APPROVED EXPENSES / POSITIONS AND IT WAS DETERMINED THAT THE CURRENTLY VACANT DEPUTY PATROL POSITION WOULD BE DELETED FOR FY2016, RESULTING IN A \$51,026 REDUCTION IN SALARIES & BENEFITS TO HELP WITH BUDGET DEFICIT AND AGREED TO PROVIDE THE REMAINING \$2,138 REDUCTION TO THE JUDGE LATER TODAY.
