- 2. PUBLIC COMMENTS: NONE.
- 3. INFORMATIONAL REPORTS:
 - A. QUARTERLY DEPARTMENTAL (ACTIVITY) REPORTS: POTENTIALLY PREVENTABLE HOSPITALIZATION PROGRAM PRESENTED BY JERRY HATHORN.
 - B. DISTRICT CLERK BOBBYE RICHARDS & COUNTY COURT AT LAW JUDGE TOM BROWN UPDATED COURT ON DISBURSING EXCESS FUNDS FROM SHERIFF'S TAX SALES TO SCHOOL DISTRICTS AND OTHER ENTITIES.
