THEREFORE, pursuant to L.G.C.§263.152(a)(1) which states the County may periodically sell its surplus property and that competitive bidding or auction is not necessary if the purchaser is another political subdivision within the County, the items herein designated shall be disposed of by sale to the City of Livingston in consideration of payment in the amount of Ten Dollars (\$10.00) per unit listed on Exhibit "A" attached hereto and payable to Polk County, Texas.
