DISCUSSION OF ITEM 9 BY JUDGE & COMMISSIONERS.

9. MOTIONED BY TOMMY OVERSTREET, SECONDED BY BOB WILLIS, TO NOT ORDER ANY RESTRICTIONS ON CERTAIN FIREWORKS IN THE UNINCORPORATED AREAS OF THE COUNTY DURING THE JULY 4TH HOLIDAY PERIOD. ALL VOTING YES.

DISCUSSION OF ITEM 10 BY JUDGE & COMMISSIONERS. NO ONE PRESENT FROM THE SHERIFF'S DEPT TO ANSWER THE COURTS QUESTIONS REGARDING ITEM 10.

- 10. MOTIONED BY MILTON PURVIS, SECONDED BY BOB WILLIS, TO TABLE "DISCUSS AND REVIEW SHERIFF'S REQUEST FOR RENEWAL OF INTERLOCAL COOPERATION AGREEMENT WITH LIBERTY COUNTY FOR CONTRACTED HOUSING OF INMATES IN THE POLK COUNTY JAIL". ALL VOTING YES.
- 11. DISCUSSION OF FY2017 BUDGET DEVELOPMENT:
 - A. REVIEW PRELIMINARY VALUES RECEIVED FROM POLK CENTRAL APPRAISAL DISTRICT. JUDGE MURPHY STATED THE INCREASE IN VALUES IS A LITTLE OVER \$2,246,000, RESULTING IN ADDITIONAL TAX REVENUE OF SLIGHTLY UNDER \$14,000 FOR FY2017.
 - B. DISCUSS FY2017 COST OF LIVING (COL) INCREASE FOR EMPLOYEES AND RETIREE COL FOR DETERMINATION OF COUNTY ANNUALLY DETERMINED CONTRIBUTION RATE (ADCR) WITH TEXAS COUNTY & DISTRICT RETIREMENT SYSTEM. JUDGE MURPHY INDICATED THAT A 2.5% COL FOR CURRENT POSITIONS AND ALL RELATED BENEFITS INCREASES WILL REQUIRE AN ESTIMATED \$326,215 IN FY2017. THE COURT AGREED TO GO FORWARD WITH THE COL INCREASE FOR EMPLOYEES AND REVIEW THE EFFECT OF A COL INCREASE FOR RETIREES. COURT ALSO DISCUSSED EMPLOYEE AWARDS BANQUET AND WOULD PREFER THE FUNDS ALLOCATED FOR THE AWARDS BANQUET GO TOWARDS COL INCREASE AS SUGGESTED BY COUNTY EMPLOYEES AND REVIEW OTHER OPTIONS FOR AN AWARDS BANQUET.
 - C. ADRENA GILBERT (HUMAN RESOURCE SUPERVISOR) DISCUSSED HEALTH & EMPLOYEE BENEFITS POOL (HEBP) RATE ESTIMATES FOR FY2017 AND WILL HAVE AN HEBP REPRESENTATIVE FROM TEXAS ASSOCIATION OF COUNTIES (TAC) MEET WITH THE COURT TO DISCUSS THE BENEFITS AND OPTIONS AT THE FIRST MEETING IN JULY 2016. JUDGE MURPHY NOTED THAT THE ESTIMATED PREMIUM INCREASE ACROSS THE

POOL IS 7.5%, BUT THAT WE EXPECT POLK COUNTY RATE INCREASE TO BE LESS.

JUDGE MURPHY ALSO UPDATED THE COURT ON NEGOTIATIONS WITH IMMIGRATION AND CUSTOMS ENFORCEMENT (ICE) FOR USE OF THE IAH FACILITY, NOTING THAT THE BUDGET IS DRAFTED WITHOUT EXPECTATION OF PER DIEM REVENUE, ALTHOUGH WE HOPE TO RE-ESTABLISH THE PER DIEM REVENUE ONCE AN ICE AGREEMENT IS REACHED. JUDGE MURPHY ALSO STRESSED HER CONCERN THAT – SHOULD THE IAH PER DIEM REVENUE FOR THE COUNTY BE RE-ESTABLISHED – THE FUNDS NOT BE USED IN SUCH A WAY AS TO CAUSE BUDGETARY DEPENDENCE (SUCH AS WAGES AND OTHER RECURRING EXPENSES) IN THE EVENT THAT THE FACILITY EXPERIENCES A FUTURE POPULATION DECLINE.

THE JUDGE ALSO NOTED THAT NO SIGNIFICANT REDUCTION IN ENERGY COST HAS BEEN DRAFTED IN THE FY2017 BUDGET UNTIL SUCH TIME THAT THE CAPITAL IMPROVEMENT ARE COMPLETED.
