JUDGE MURPHY INFORMED THE COURT OF FLSA RULE CHANGES TAKING EFFECT DECEMBER

1, 2016 REGARDING EMPLOYEES SUBJECT TO OVERTIME AND NOTED THAT DEPARTMENT

HEADS AND ELECTED OFFICIALS SHOULD MONITOR THE AMOUNT OF FLSA OVERTIME

ACCRUED BY EMPLOYEES TO AVOID TIME AND HALF PAYOUTS THAT WILL IMPACT DEPARTMENT BUDGETS. SHE ENCOURAGED SUPERVISORS TO UTILIZE EXISTING POLICIES IN MANAGING OVERTIME WORKED AND TO SCHEDULE TIME OFF, PREFERABLY WITHIN THE SAME WORK PERIOD.
