PUBLIC HEARING REGARDING THE PROPOSED ISSUANCE BY THE COLORADO HEALTH FACILITIES AUTHORITY ("COHFA") OF TAX-EXEMPT BONDS (THE "COHFA BONDS"), THE PROCEEDS OF WHICH WILL BE LOANED TO CATHOLIC HEALTH INITIATIVES, A COLORADO NONPROFIT CORPORATION. ("CHI").

JUDGE MURPHY DISCUSSED THE PORTION OF THE PROPOSED COHFA BONDS FOR WHICH HOST APPROVAL IS BEING REQUESTED FROM POLK COUNTY IN AN AMOUNT NOT TO EXCEED \$60,000,000 THAT WILL BE USED IN THE COUNTY TO FINANCE AND/OR REFINANCE THE COSTS OF THE ACQUISITION OF CERTAIN HEALTH CARE AND RELATED FACILITIES OF MEMORIAL HEALTH SYSTEM OF EAST TEXAS (MHSET) AND ITS SUBSIDIARIES AND AFFILIATES, AS WELL AS CERTAIN COSTS OF CONSTRUCTING, RENOVATING AND EQUIPPING THOSE FACILITIES (COLLECTIVELY, THE "PROJECTS'), INCLUDING EMERGENCY ROOM IMPROVEMENTS AND PURCHASE OF AN MRI AT THE CHI ST. LUKE'S MEMORIAL HOSPITAL IN LIVINGSTON.
