#### 12. BUDGET WORKSHOP:

RECEIVED TAX ASSESSOR COLLECTOR'S EFFECTIVE TAX RATE CALCULATION OF \$0.6600 AND VERIFICATION OF 96% COLLECTION RATE FOR FY2017.

JUDGE MURPHY DISCUSSED FY2017 PROPOSED SALARIES, EXPENSES & ALLOWANCES OF ELECTED OFFICIALS NOTING THAT 2.5% COST OF LIVING INCREASE WOULD BE ACROSS THE BOARD, BUT NO INCREASE WAS MADE IN TRAVEL ALLOWANCES DUE TO REDUCTION IN FUEL COSTS.

JUDGE MURPHY REVIEWED THE DRAFT BUDGET INFORMATION WITH THE COURT, INCLUDING CERTIFIED VALUES, REVENUE CHANGES AND EXPENSES.

TAX ASSESSOR COLLECTOR LESLIE BURKS DISCUSSED COLLECTION RATE.

MOTIONED BY TOMMY OVERSTREET, SECONDED BY BOB WILLIS, TO ELIMINATE DRAFT BALANCE IN DEBT SERVICE (\$14,955.12) BY REDUCING DEBT SERVICE PORTION OF 2016 TAX RATE TO 0.1122.

JUDGE MURPHY DISCUSSED THE FOLLOWING WITH COURT:

ROAD & BRIDGE CAPITAL LEASE AMOUNTS WILL BE UPDATED WITH FIGURES TO BE PROVIDED BY THE COUNTY AUDITOR;

DISCUSSED DEBT SCHEDULE - RETIRING DEBT AND NEW DEBT PAYMENTS;
CHANGES IN ESTIMATED REVENUES SINCE THE COURT'S PREVIOUS DISCUSSION
ANNUAL AWARDS BANQUET (COURT AGREED NOT TO REINSTATE)
ENERGY SAVINGS PROGRAM - MINIMAL BUDGET CONSIDERATION FOR FY2017;
CHANGES RESULTING FROM DISTRICT JUDGES HEARING ON COUNTY AUDITOR
SALARIES:

NO CHANGES TO VOLUNTEER FIRE DEPARTMENT FUNDING;
REDUCTIONS MADE IN SHERIFFS OFFICE FUEL, BASED ON YEAR END ESTIMATES;
NOTED THAT LATERAL ROAD FUND BALANCE WAS INCORRECTLY REFLECTED ON
DRAFT BUDGET AND HAS ALREADY BEEN INCLUDED IN PRECINCT FUND BALANCES;
WASTE MANAGEMENT ESTIMATED INCREASE, BASED ON JULY 2016 RATE CHANGE;
CAPITAL PURCHASE REQUESTS

SHERIFF KENNETH HAMMACK & JOHN SANDERS DISCUSSED REQUEST FOR DEPT.

PURCHASE OF VEHICLES IN FY2017 AND COST PER VEHICLE. USE OF VEHICLES TO BE

TRADED WAS ALSO DISCUSSED. JAY BURKS NOTED THAT MAINTENANCE DEPT. COULD

POSSIBLY USE S.O. TRADE RATHER THAN PURCHASING NEW VEHICLE IN FY2017.

THE COURT REVISED THE FY2017 CAPITAL PURCHASE PROJECTIONS FOR VEHICLES TO (10) IN THE SHERIFF'S OFFICE, (1) FOR INFORMATION TECHNOLOGY, (1) FOR EMERGENCY MANAGEMENT AND (1) FOR CONSTABLE PRECINCT 2. THE COURT ALSO DETERMINED THAT THE FUTURE GOAL FOR FLEET ROTATION FOR THE SHERIFF'S OFFICE WOULD BE 10 VEHICLES PER YEAR.

DISCUSSION OF SALARIES OF ELECTED OFFICIALS & STAFFING CHANGES, NOTING THE ADJUSTMENT OF JP'S SALARY/TRAVEL AMOUNTS.

JUDGE MURPHY STATED THE PROPOSED BUDGET WOULD BE FILED WITH THE COUNTY CLERK AND POSTED ON THE COUNTY WEBSITE BY AUGUST 19, 2016.
