JUDGE MURPHY DISCUSSED ITEM 10.

10. MOTIONED BY MILTON PURVIS, SECONDED BY TOMMY OVERSTREET, APPROVAL OF A FEE AGREEMENT (IN THE AMOUNT OF \$90,000) FOR PROFESSIONAL SERVICES BETWEEN POLK COUNTY AND MPTX ASSOCIATES FOR HAZARD MITIGATION PLAN UPDATE. ALL VOTING YES.

JUDGE MURPHY DISCUSSED THE RATING COMMITTEE'S RECOMMENDATION FOR ADMINISTRATION AND ENGINEERING SERVICES FOR THE 2017-18 CDBG PROGRAM. IT WAS RECOMMENDED TO SELECT KSA FOR ENGINEERING SERVICES AND DAVID J. WAXMAN, INC. FOR GRANTS ADMINISTRATION. COMMISSIONER WILLIS ASKED WHO SUBMITTED RESPONSES AND JUDGE MURPHY READ THE LIST OF THE COMPANIES. COMMISSIONER OVERSTREET ALSO DISCUSSED THE RATING PROCESS.

JUDGE MURPHY AND COMMISSIONER OVERSTREET DISCUSSED THE CANCELLATION NOTICE AND TERMINATION OF INTERLOCAL AGREEMENT RECEIVED FROM THE CITY OF HUNTSVILLE FOR LANDFILL SERVICES. 12. MOTIONED BY BOB WILLIS, SECONDED BY TOMMY OVERSTREET, TO RECEIVE NOTICE OF CANCELLATION AND TERMINATION OF INTERLOCAL AGREEMENT WITH CITY OF HUNTSVILLE FOR LANDFILL SERVICES, EFFECTIVE JANUARY 3, 2017. ALL VOTING YES.

DISCUSSION OF AGENDA ITEM 13 BY JUDGE MURPHY, NOTING THE EMPLOYEES THAT WILL BE EFFECTED BY THE FLSA RULE CHANGE WHICH INCREASES THE WAGE THRESHOLD FOR QUALIFICATION AS AN EXEMPT EMPLOYEE ON DECEMBER 1, 2016.

13. MOTIONED BY TOMMY OVERSTREET, SECONDED BY BOB WILLIS, THAT THE EXTRA HOURS RECORDED BY EXEMPT EMPLOYEES THAT WILL MOVE TO THE "NON-EXEMPT" CATEGORY WILL BE APPLIED TO EQUIVALENT TIME AND ARE TO BE USED WITHIN THE NEXT 13 MONTHS (BY DECEMBER 31, 2017). ALL VOTING YES.

COMMISSIONER WILLIS ADDRESSED AN ISSUE ONE OF HIS EMPLOYEES HAD WITH HR NOT ASSISTING THE EMPLOYEE WITH TYPING A LETTER SO THAT THE EMPLOYEE COULD BEGIN GETTING HIS PAYROLL PRINTED AND ATTACHED WITH LEAVE BALANCE SHEET INSTEAD OF BEING EMAILED. HE INFORMED HUMAN RESOURCE SUPERVISOR ADRENA GILBERT TO COME GET THE LETTER FROM HIM AND THAT SHE WAS DOING AN INJUSTICE TO THE COUNTY EMPLOYEES. AND ADVISED HER THAT IF ANOTHER ISSUE CAME UP THAT THEY WOULD HAVE ANOTHER DISCUSSION JUST LIKE THIS ONE.
