#### 12. DISCUSSION OF FY2018 BUDGET DEVELOPMENT:

- A. REVIEW PRELIMINARY VALUES RECEIVED FROM POLK CENTRAL APPRAISAL DISTRICT.
- B. DISCUSSION REGARDING FY2018 COST OF LIVING (COL) INCREASE OF 2.5% FOR EMPLOYEES AND ELECTED OFFICIALS (SALARIES ONLY) AND GET ESTIMATES TO SEE WHAT THE COST WOULD BE TO GIVE A 1.5 & 2.5% COST OF LIVING INCREASE TO RETIREES.
- C. DISCUSSION OF HEALTH & EMPLOYEE BENEFITS POOL (HEBP) RATE ESTIMATES FOR FY2018, NOTING THE INITIAL ESTIMATE THAT RATES MAY INCREASE 5%.
- D. JUDGE MURPHY DISCUSSED HIGHLIGHTS OF PRELIMINARY BUDGET WHICH INCLUDES 4 NEW JAILER POSITIONS, NOTING JAILERS NOW HAVE TO HAVE A FOOD HANDLERS LICENSES FOR PREPARING MEALS, CHANGES TO GUARDIANSHIPS WILL REQUIRE ADDITIONAL STAFF, DISPATCHERS ARE OVERLOADED AND JAIL MEDICAL IS BEING REVIEWED AND MAY REQUIRE ADDITIONAL STAFF. THE JUDGE ALSO STATED THE COUNTY HAD RECEIVED A BLOCK PAYMENT FOR RETROACTIVE PAY FROM IAH WHICH COURT WILL NEED TO DECIDE WHAT TO DO WITH THOSE FUNDS.
