 JUDGE MURPHY DISCUSSED NECESSARY CHANGES TO THE BUDGET PLANNING CALENDAR

 DUE TO SENATE BILL 2 APPROVED IN THE 86TH LEGISLATIVE SESSION. THE COURT WILL

 NEED TO ADOPT A 2020 TAX RATE & FY2021 BUDGET ON AUGUST 11TH, SO ALL BUDGET

 PREPARATION ACTIVITIES MUST BE MOVED UP BY 4-6 WEEKS. BECAUSE NO CHANGES

HAVE BEEN MADE TO THE APPRAISAL DISTRICT DEADLINES, CERTIFIED APPRAISAL VALUES ARE STILL DUE TO THE TAX ASSESSOR/COLLECTOR NO LATER THAN JULY 25TH IN ORDER TO CALCULATE THE TAX RATES APPLICABLE TO THE FY2021 BUDGET. THE PROPOSED BUDGET MUST BE PREPARED IN JUNE, USING ESTIMATED VALUES TO PROJECT FY2021 REVENUE. A SPECIAL SESSION IS NEEDED FOR AUGUST 4TH TO RECEIVE THE TAX RATE CALCULATIONS FROM THE TAX ASSESSOR/COLLECTOR AND FOR A FINAL BUDGET WORKSHOP TO DETERMINE IF THERE WILL BE SUFFICIENT FUNDS FOR THE PROPOSED BUDGET AS WRITTEN AND WHAT ITEMS WILL NEED TO BE CUT IF THE REVENUE IS INSUFFICIENT. JUDGE MURPHY NOTED THAT THIS NEW TIMELINE WILL DECREASE TRANSPARENCY BECAUSE THERE WILL BE SUBSTANTIALLY LESS TIME FOR THE PUBLIC TO REVIEW THE PROPOSED FY2021 BUDGET WITH AN ACCURATE REVENUE PROJECTION OR FOR THE COURT TO DISCUSS ANY NECESSARY CHANGES WITH OTHER ELECTED OFFICALS AND DEPARTMENTS. THE ORDER TO SET REGULAR TERMS OF COMMISSIONERS COURT FOR FY2021 WILL INCLUDE ADDITIONAL MEETINGS IN AUGUST FOR BUDGET PREPARATION/ADOPTION AND TO MEET STATUTORY DEADLINES.
