B. MOTIONED BY BOB WILLIS, SECONDED BY RONNIE VINCENT, TO APPROVE OPTION 1 FOR EMPLOYEE HEALTH COVERAGE-MAJOR MEDICAL. DEDUCTIBLE WILL INCREASE \$250 FOR BOTH IN/OUT NETWORK, NO CHANGE TO CO-INSURANCE PERCENTAGE, CO INSURANCE MAXIMUM WILL INCREASE BY \$500 IN NETWORK/ \$1,000 OUT OF NETWORK, NO CHANGE TO CO-PAYMENTS FOR OFFICE VISITS, EMERGENCY ROOM VISIT WILL INCREASE BY \$50, NO CHANGE IN PRESCRIPTION COVERAGE. EMPLOYEE PREMIUM WILL DECREASE FROM \$903.16 TO \$845.54, DEPENDENT COSTS TO THE EMPLOYEE WILL DECREASE BY \$84.36/MONTH FOR CHILDREN, \$105.28/MONTH FOR SPOUSE AND \$123.76/MONTH FOR FAMILY. 11. DISCUSSION OF FY2021 BUDGET DEVELOPMENT.

AD VALOREM TAX REVENUE BUILT INTO DRAFT BUDGET IS CURRENTLY BASED ON ESTIMATES. CERTIFIED VALUES AND RAILROAD ROLLING STOCK WILL NOT BE AVAILABLE UNTIL THE END OF JULY. FY2021 BUDGET WILL NEED TO BE APPROVED ON AUGUST 11.

DEBT SERVICE COLLECTION RATE IS BASED ON LOWEST ACTUAL COLLECTION RATE FROM PREVIOUS THREE YEARS (99.22%) AS REQUIRED BY LEGISLATION.

THE TAX RATE USED TO BUILD THE BUDGET IS 0.6461/\$100, WHICH IS THE SAME AS THE PRVEVIOUS YEAR. THE AD VALOREM TAX REVENUE BUILT INTO THE GENERAL FUND AND ROAD & BRIDGE ARE BASED ON 95% COLLECTION RATE, AS RECOMMENDED DUE TO THE STATE OF THE ECONOMY AND MARKETS AT THIS TIME.

REVIEWED DEBT SERVICE SCHEDULE, AND NOTED THAT JUDICIAL CENTER DEBT WILL ROLL OFF AFTER 2023 AND JAIL EXPANSION DEBT WILL ROLL OFF AFTER 2027. IF WE CAN MAINTAIN LOW DEBT ISSUANCE FOR THE NEXT SEVERAL YEARS, THE AMOUNT OF DEBT SERVICE FUNDS NEEDED WILL DROP SIGNIFICANTLY FROM WHERE THEY ARE NOW.

REVIEWED APPROVED CAPITAL PURCHASES & TAX NOTES FROM LAST FIVE YEARS.

REVIEWED PERSONNEL EXPENSES BY DEPARTMENT / STAFFING PATTERNS - LARGEST EXPENDITURE IN BUDGET. NEARLY \$1.5M INCREASE IN PERSONNEL BUDGET IN THE LAST 5 YEARS.

REVIEWED TRAVEL/TRAINING – EXPECTING SHORTFALL THIS YEAR, SO THIS IS ONE PLACE EXPENSES CAN BE CUT. DUE TO COVID-19, THERE ARE MORE OPPORTUNITIES TO RECEIVE NECESSARY TRAINING ONLINE, WHICH IS LESS EXPENSIVE THAN ATTENDING CONFERENCES. WE ARE ALREADY SEEING A REDUCTION IN TRAVEL/TRAINING EXPENSES FOR FY2020 DUE TO THE VIRUS.

REVIEWED CHANGES TO FY2021 DRAFT BUDGET VS FY2020 ADOPTED BUDGET.

REVIEWED ROAD & BRIDGE REVENUE CALCULATION - LOWERED FROM LAST YEAR DUE TO LOWER ESTIMATED NET APPRAISAL VALUE AND LOWER EXPECTED COLLECTION RATES.

COMMISSIONER WILLIS ASKED ABOUT NUISANCE ABATEMENT POLICY AND JUDGE MURPHY CONFIRMED IT HAD BEEN FORWARDED TO ALL COMMISSIONERS FOR REVIEW AND WOULD BE ON THE NEXT AGENDA.
