

NOTICE BY THE POLK COUNTY COMMISSIONERS COURT

of increases in Elected Officials Salaries, Expenses and Allowances for FY2021

Pursuant to Local Gov't Code, Sec. 152.013(b)(1)(2), notice is hereby given of proposed increases in elected county/precinct officials' salaries, expenses and allowances for the fiscal year beginning October 1, 2020. These changes represent the annual increase in Longevity Pay (to \$1,200 max.) and any other changes proposed. The Polk County Commissioners Court will set the FY2021 compensation for elected county/precinct officials in a regular session to be held August 11, 2020 at 10:00 a.m. in the Commissioners Courtroom of the Polk County Courthouse, Livingston, Texas.
