AMENDMENT NO. 22

 - ☑ allotting additional funding for Fiscal Year 2020 in the amount of \$11,278.44 (FY20 Total Budget \$220,099.50), which is based on an additional 2,124 units (FY20 Total Units 41,450) at a unit rate of \$5.31 per home-delivered meal; or
 - □ decreasing funding for Fiscal Year [YYYY] in the amount of \$[\$\$.\$\$] (FY[YY] Total Budget \$[\$\$.\$\$]), which is based on a reduction of [####] units (FY[YY] Total Units [#####]) at a unit rate of \$[\$.\$\$] per home-delivered meal.
- 2. The Contract is amended by:
 - ☑ adding funds for Fiscal Year 2021 in the amount of \$37,297.44 (FY21 Total Budget \$246,118.50), which is based on an additional 7,024 units (FY21 Total Units 46,350) at a unit rate of \$5.31 per home-delivered meal; or
 - □ decreasing funds for Fiscal Year [YYYY] in the amount of \$[\$\$.\$\$] (FY[YY] Total Budget \$[\$\$.\$\$]), which is based on a reduction of [####] units (FY[YY] Total Units [####]) at a unit rate of \$[\$.\$\$] per home-delivered meal.
- 3. This Amendment shall be effective as of September 1, 2020.

Except as amended and modified herein, the terms and conditions of the Contract remain in full force and effect.
