

PETITION FOR THE ABANDONMENT, CLOSURE, OR VACATION OF A PORTION OF A PUBLIC ROAD IN POLK COUNTY, TEXAS

DATE: December 3, 2020

TO THE COMMISSIONER'S COURT OF POLK COUNTY, TEXAS:

Applicant, Pine Forest Baptist Church, a not-for-profit corporation, hereby make this application for the vacation, abandonment, and/or closure of a portion of one third-class public roads in Polk County, Texas, which are not located within the bounds of any municipality. Pursuant to §251.016 of the Texas Transportation Code, the Commissioners Court may exercise general control over all roads in the county.

A copy of the official petition of all of the abutting property owners requesting said closure or abandonment, is attached hereto as Exhibit A and incorporated by reference.

The public road, a portion of which is sought to be abandoned, closed, or vacated is named Schelske Lane. This road sought to be abandoned is 0.8416 acre of land situated in the M. Chavence Survey, Abstract No. 164, Polk County, Texas. A depiction of the portion of these roads sought to be abandoned, closed, or vacated is highlighted yellow on the survey attached hereto as Exhibit B and incorporated by reference. The metes and bounds of the area sought to be abandoned, closed, or vacated is attached as Exhibit C.

Applicant agree to hold Polk County harmless, and indemnify it against all suits, costs, expenses, and damages that may arise or grow out of this request for closure and abandonment.

By Applicant's signature on this petition, Applicant agrees to pay the costs of the appraisal and conducting of a title search of the property and the administrative fee associated hereto. Applicant understands that without the payment of such costs, the County will not proceed with appraisal of the roadways that Applicant requests be abandoned and vacated. Applicant also understand that these costs and fees are not refundable.

Abandonment of such property is proposed because, the portions of the road sought to be abandoned, vacated, or closed, the road is no longer in use and an alternative route for access has been established for some time as shown in the highlighted blue area on Exhibit B attached hereto. The road has not been utilized by the public for some time, and portions of the roads located were never developed and maintained appropriately.
