MOTIONED BY RONNIE VINCENT, SECONDED BY MILTON PURVIS, TO RECEIVE NUISANCE ABATEMENT HEARING DETERMINATION FROM JUSTICE OF THE PEACE PCT 2 SARAH RASBERRY FOR CAUSE #A00470, APPROVE ORDER TO ABATE NUISANCE AND ASSESS THE COST OF ABATEMENT PLUS FEES AND INTEREST TO THE PROPERTY OWNER. ALL VOTING YES.
- 15. RECEIVE PRESENTATION OF U.S. DEPARTMENT OF JUSTICE EQUITABLE SHARING PROGRAM FROM POLK COUNTY RESERVE DEPUTY CONSTABLE, PRECINCT 1 BEAU PRICE.
- 16. DISCUSSION WITH JUSTICE OF THE PEACES AND TYLER TECHNOLOGIES REGARDING ODYSSEY JUDICIAL SOFTWARE. EACH JP EXPRESSED CONCERNS WITH THEIR OFFICES MOVING FORWARD WITH THE CONVERSION TO ODYSSEY JUDICIAL SOFTWARE AND THEIR DESIRE TO STAY WITH THE CURRENT PROVIDER. REPRESENTATIVES FROM TYLER TECHNOLOGIES, STEPHEN STEHLING AND GINA SEWELL, AGREED THAT TYLER

TECHNOLOGIES HAD NOT PROVIDED SERVICES THAT LIVE UP TO THEIR STANDARDS. SOME OF THE TEAM MEMBERS ORIGINALLY ASSIGNED TO OUR PROJECT WERE MOVED TO OTHER PROJECTS AND REPLACED WITH LESS QUALIFIED TEAM MEMBERS. THOSE TEAM MEMBERS WERE NOT RELAYING THE PROBLEMS THAT POLK COUNTY STAFF WERE HAVING TO SENIOR MANAGEMENT, AND SO THEY WERE UNAWARE OF THE ISSUES WE WERE FACING, CAUSING THE PROJECT TO BE SUBSTANTIALLY DELAYED AND FORCING POLK COUNTY STAFF TO DUPLICATE WORK, STEHLING AND SEWELL STATED THAT THEY NOW HAVE THE CORRECT TEAM IN PLACE AND THAT ALL ISSUES THE JP JUDGES ARE HAVING ARE MANAGEABLE GIVEN SUFFICIENT TIME TO ADDRESS THEM. TYLER TECHNOLOGIES IS WILLING TO ENSURE THE SUCCESS OF THIS CONVERSION WHILE EATING THEIR COST OF THE EXTENDED "GO LIVE". JUDGE MURPHY STATED THAT STAYING WITH THE CURRENT PROVIDER IS NOT AN OPTION THE COURT CAN CONSIDER, SO IT IS EITHER MOVE FORWARD WITH TYLER TECHNOLOGIES. OR FIND ANOTHER SOFTWARE FOR THE JP OFFICES THAT CAN COMMUNICATE WITH ODYSSEY, SINCE THAT IS THE DIRECTION ALL OTHER OFFICES ARE GOING. THE COURT ASKED THE JP JUDGES TO MEET WITH STEHLING AND SEWELL AFTER COURT AJOURNS TO SEE IF THEY CAN COME TO TERMS.
