**FINAL JUDGMENT**

Be it remembered that on this date came to be considered for trial the above-styled and numbered cause, filed on March 6, 2019. The Respondent, **OSARETIN HAMMOND EDOKPAYI**, by and through his attorney, Jed Silverman, filed their Answer to Plaintiff's Original Notice of Seizure and Forfeiture on March 14, 2019.

Plaintiff, the State of Texas, appeared, represented by its Assistant District Attorney for Harris County, Texas. Plaintiff having announced "ready," and no jury having been requested, the case was called to trial. Upon no appearance by the Respondent, **OSARETIN HAMMOND EDOKPAYI**, trial was had to the court. Upon Plaintiff's oral motion, the Court finds, pursuant to Rule 198 of the Texas Rules of Civil Procedure, that Respondent, **OSARETIN HAMMOND EDOKPAYI** failed to serve Plaintiff with timely responses to Plaintiff's Request for Admissions, which were served upon the Respondent on August 19, 2019. The Court finds that all matters separately set forth in Plaintiff's Request for Admissions are deemed admitted and conclusively established as to Respondent **OSARETIN HAMMOND EDOKPAYI**.

The Court has jurisdiction of the subject matter and parties, and Final Judgment should be granted herein. It is therefore:


**ORDERED, ADJUDGED, AND DECREED** that the ONE 2015 TOYOTA HIGHLANDER, VIN 5TDDKRFH1FS224672, is contraband and forfeited to the State of Texas and awarded to the Polk County Constable Precinct one (1). It is further **ORDERED, ADJUDGED, and DECREED** that the State of Texas is hereby authorized and directed to issue good and sufficient title to the ONE 2015 TOYOTA HIGHLANDER, VIN 5TDDKRFH1FS224672, such that will perfect title in the Polk County Constable

Precinct one (1). It is FURTHER ORDERED that, pursuant to Article 59.06(b) of the Texas Code of Criminal Procedure, the Polk County Constable Precinct One is hereby authorized to use, maintain, repair, and operate the said ONE 2015 TOYOTA HIGHLANDER, VIN 5TDDKRFH1FS224672 after the Polk County Constable Precinct One (1) has paid to have the aftermarket hidden compartment(s) removed from said vehicle, and after the Polk County Constable Precinct One (1) has paid all towing and storage charges, if any, which may have accrued against said vehicle.

Costs of court are charged against the Respondent **OSARETIN HAMMOND EDOKPAYI**. All relief not granted herein is denied. This judgment finally disposes of all parties and all claims and is appealable.

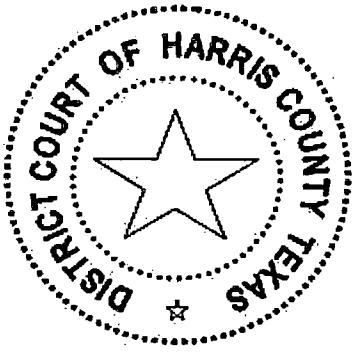
