WHEREAS, the Office of the Governor Economic Development and Tourism (OOGEDT) through the Economic Development Bank (the "Bank") will consider Corrigan OSB, L.L.C. as a Double Jumbo Enterprise Project pursuant to a nomination and an application made by the County; and

WHEREAS, pursuant to Chapter 2303, Subchapter F of the Texas Enterprise Zone Act, Texas Government Code (the "Act"), Corrigan OSB, L.L.C. has applied to the County for designation as a Double Jumbo Enterprise Project; and

WHEREAS, the County finds that Corrigan OSB, L.L.C. represented to the County that it meets the criteria for designation as a Double Jumbo Enterprise Project under Chapter 2303, Subchapter F of the Act on the following grounds:

- 1. Corrigan OSB, L.L.C. is a "qualified business" under Section 2303.402 of the Act since it will be engaged in the active conduct of a trade or business at a qualified business site within the governing body's jurisdiction and at least thirty-five percent (35%) of the business' qualifying new jobs will be filled by residents of an enterprise zone, economically disadvantaged individuals or veterans; and
- 2. There has been and will continue to be a high level of cooperation between public, private, and neighborhood entities within the area; and

3. The designation of Corrigan OSB, L.L.C. as a Double Jumbo Enterprise Project will contribute significantly to the achievement of the plans of the County for development and revitalization of the area; and

WHEREAS, the County finds that Corrigan OSB, L.L.C. meets the criteria for tax relief and other incentives adopted by the County and nominates Corrigan OSB, L.L.C. for Enterprise Project status on the grounds that it will be located at the qualified business site, will create a higher level of employment, economic activity and stability; and

WHEREAS, the County finds that it is in the best interest of the County to nominate Corrigan OSB, L.L.C. as a Double Jumbo Enterprise Project pursuant to the Act;
