## 12. FY2022 EMPLOYEE BENEFITS:

A. MOTIONED BY RONNIE VINCENT, SECONDED BY TOMMY OVERSTREET, TO SET THE ANNUALLY CONTRIBUTION RATE FOR TEXAS COUNTY & DISTRICT RETIREMENT SYSTEM AT THE MINIMUM RATE OF 15.46%, A 1.25% INCREASE FROM THE FY2021 RATE.

B. MOTIONED BY GUYLENE ROBERTSON, SECONDED BY RONNIE VINCENT, TO APPROVE OPTION 2 FOR EMPLOYEE HEALTH COVERAGE – MAJOR MEDICAL. DEDUCTIBLE WILL INCREASE \$750 FOR IN-NETWORK AND \$3,500 FOR OUT-OF-NETWORK; NO CHANGE TO CO-INSURANCE PERCENTAGE; CO-INSURANCE MAXIMUM WILL INCREASE BY \$500 IN-NETWORK AND \$1,000 FOR OUT-OF-NETWORK; CO-PAYMENTS FOR OFFICE VISITS WILL INCREASE BY \$5; NO CHANGE FOR EMERGENCY ROOM VISIT OR PRESCRIPTION COVERAGE. THE HUMAN RESOURCES SUPERVISOR ADVISED THE COURT THAT THE COUNTY MAY BE ABLE TO SEE A REDUCTION IN PREMIUMS IN FUTURE YEARS IF WE HAD MORE EMPLOYEE PARTICIPATION IN PROGRAMS OFFERED BY TEXAS ASSOCIATION OF COUNTIES FOR CONTROLLING WEIGHT LOSS, HYPERTENSION AND DIABETES.

VERY FEW PEOPLE ARE CURRENTLY PARTICIPATING IN THESE PROGRAMS AND THE MAJORITY OF OUR CLAIMS COULD BE ELIMINATED BY INCREASED PARTICIPATION.
