- -OFFICES NEEDING ADDITIONAL STAFF: AUDITOR (TRANSITION PART-TIME TO FULL-TIME), IT, JP#4 (PART TIME CLERK) AND THE SECRETARY FOR AGRILIFE EXTENSION WILL BE FUNDED FROM GENERAL BALANCE AND NO LONGER SUBSIDIZED BY ROAD & BRIDGE. -5% COST OF LIVING RAISE FOR EVERY EMPLOYEE AND ADDING MERIT FUNDS IN EACH DEPARTMENT.
