## ORDER

### Authorizing and Assigning space in County-owned Buildings

**WHEREAS**, Counties are permitted and encouraged to provide space in county-owned buildings to private and other entities which serve as agents of the public and which promote or carry out a county purpose; and,

**WHEREAS**, such entities have requested office space which is available within certain county-owned buildings and this Court finds that the provision of space to the requesting entities will serve a county purpose;

#### **NOW, THEREFORE BE IT RESOLVED THAT:**

That the Commissioners Court of Polk County, Texas hereby authorizes and assigns the use of space located in the county-owned building referenced herein to the following entities:



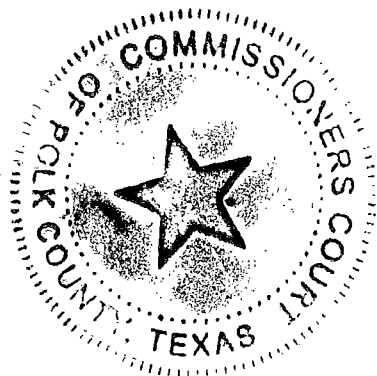
**BE IT FURTHER ORDERED** that the County shall not charge a fee to the listed entities for the use of said space/s.
