RE; Pay all Compensation, FLSA, Holiday and Vacation Time

I am requesting that the Commissioner's Court pay all Compensation, FLSA, Holiday and Vacation time, as well lost Vacation time from October 1, 2021 – February 13, 2022, due to factors beyond my control.

COVID outbreaks, extended sick periods and staff shortages have made it impossible to grant days off or approve vacation requests. The staff members in the Jail have been working extended shifts as well as extra shifts performing the day to day duties in order to keep our Jail in compliance with Jail Commission Standards. Several Corrections Officers have lost accrued Vacation time, which has been extended but are still unable to use due to staff shortages.

I am requesting we be able to pay all lost vacation time and those vacation hours which have been extended along with FLSA, Comp and Holiday time from October 1, 2021 - February 13, 2022.

<u>Please see the attached spreadsheet which indicates the time, I am requesting be paid</u> to the individual employee.

I feel that this would be a much needed morale boost to our jail staff if they were to be compensated for time worked and the benefits earned.
