On February 2, 2022, the County received construction bids from two (2) contractors for the referenced project. A tabulation of bids is attached and summarized below:

Additive Alternate Bid 1	\$12,000.00	\$56,000.00

Base Bid includes minor rehabilitation of the existing tank and construction of a new 40,000 gallon bolted ground storage tank.

Alternate Bid 1 includes minor rehabilitation of the existing tank and construction of a new 40,000 gallon welded ground storage tank.

Alternate Bid 2 includes minor rehabilitation of the existing tank and construction of a new 60,000 gallon bolted ground storage tank.

Alternate Bid 3 includes minor rehabilitation of the existing tank and construction of a new 60,000 gallon welded ground storage tank.

Additive Alternate Bid 1 includes the installation of level gauges in lieu of pressure gauges on both tanks.

The Low Bid was received from Duplichain Contractors.


To the Polk County Commissioner's Court,
