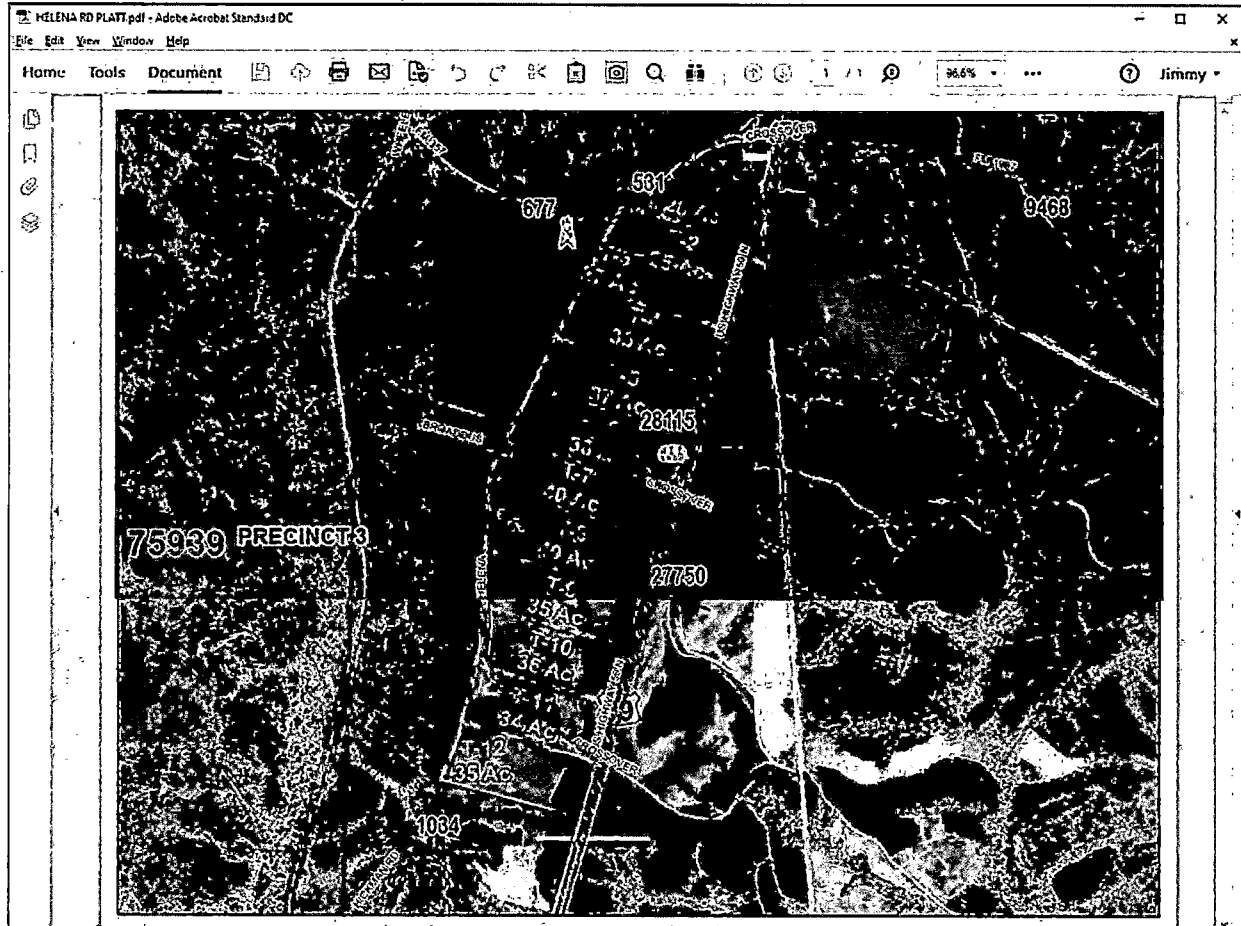

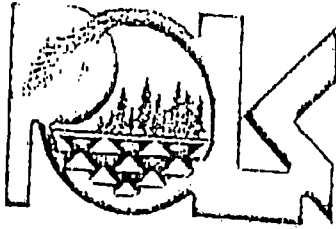
Commissioner Purvis,

#2 San Francisco from the beginning at FM 1988 to the end of the road.

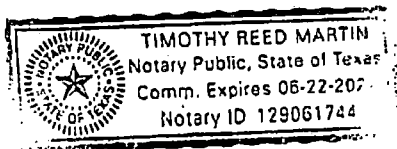
Approximate Distance: #1 Gokey Rd — 0.12 miles, #2 San Francisco— approximately, 0.08 miles
