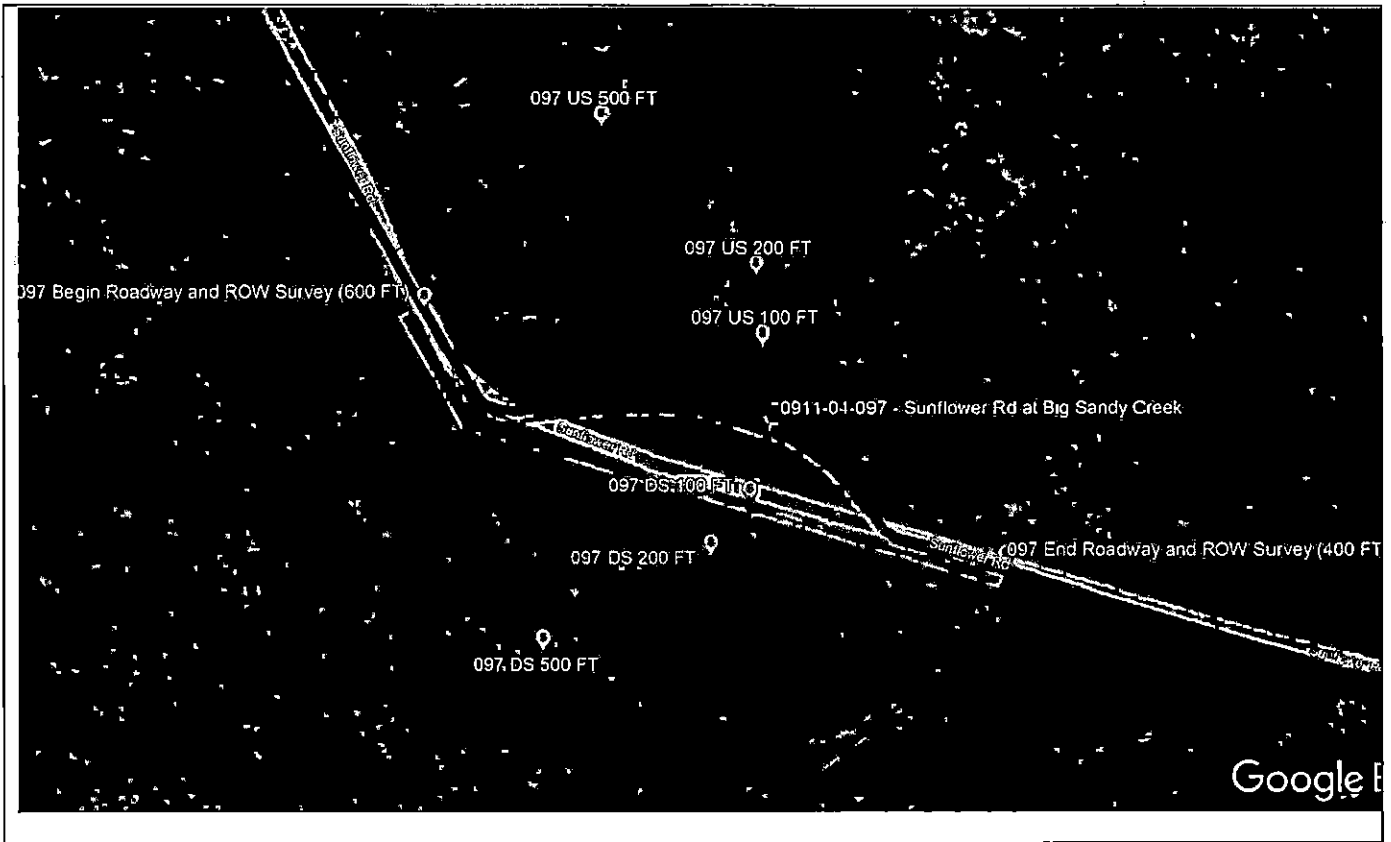

<p>Polk County is respectfully requesting permission to allow TxDOT and its' agents to enter Big Thicket National Preserve and perform the following data collection services, including but not limited to survey, environmental testing, and other applicable non-destructive engineering services within the project limits for mapping and design purposes related to proposed bridge and drainage improvements.</p> <p>Surveys may require small soil pits to be dug and filled prior to leaving the sites and removal of small vegetation (i.e. shrubs, underbrush, etc.) to create walking lanes and improve visibility, however no large timber will be disturbed. For hydraulic modeling, surveyors will also need to survey channel sections at intervals of 100 ft, 200 ft, and 500 ft, upstream and downstream from the existing bridge structure.</p> <p>See anticipated limits below:</p>

The data collection will be located along Sunflower Rd/CR 1077 from approximately 0.2 miles north of Big Sandy Creek to approximately 0.2 miles east of Big Sandy Creek. Proposed improvements for the design project include bridge replacement and roadway approach reconstruction on Sunflower Rd/CR 1077 for the limits described above.



IMPORTANT NOTICE TO APPLICANT

This is an application *only* and does not serve as permission to conduct any special activity in the park. The information provided will be used to determine whether a permit will be issued. Send the completed application along with the application fee in the form of a [application fee waived] to [not applicable] at the park address found on the first page of this application.

If your request is approved, a permit containing applicable terms and conditions will be sent you. The permit must be signed by the responsible person and returned to the park for final approval by the Park Superintendent before the permitted activity may begin.

Customers Making Payment by Personal Check
