
### **Activity Details**

# Description of Proposed Activity (attach diagram and/or additional pages, if necessary)

Polk County is respectfully requesting permission to allow TxDOT and its' agents to enter Big Thicket National Preserve and perform the following data collection services: geotechnical investigation and survey.

For geotechnical investigation, 1 soil boring will be drilled at each end of the existing timber crossing along Sunflower Rd/CR 1077 at Big Sandy Creek. These borings will be drilled to a maximum depth of 80' below existing grade, and will be backfilled with grout after the drilling is complete. This drilling will be conducted with a partial lane closure with little to no impact to the surrounding vegetation, and through traffic may be maintained adjacent to the truck mounted drilling rig. The drilling rig will not be able to cross the existing timber structure due to the existing load limitations, thus 1 day is being proposed for drilling on either side of the existing bridge.

Once complete, a survey crew will locate the boring locations and gather x, y, z coordinate locations.

The data collection will be located along Sunflower Rd/CR 1077 from approximately 0.2 miles north of Big Sandy Creek to approximately 0.2 miles east of Big Sandy Creek. Proposed improvements for the design project include bridge replacement and roadway approach reconstruction on Sunflower Rd/CR 1077 for the limits described above.
