
Dear Judge Murphy:

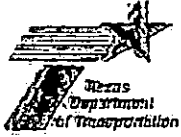



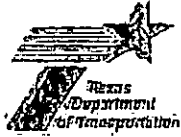
