- We require a written or e-mail confirmation for our records.

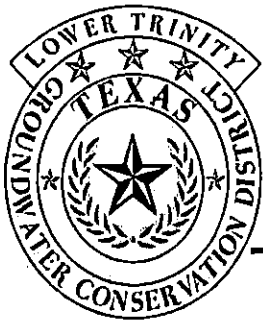
