## CONSTRUCTION CONTRACT

THIS AGREEMENT made this the <u>22nd</u> day of <u>December, 2023</u> by and between <u>Pheonix</u> <u>Fabricators and Erectors, Inc.</u> hereinafter called the "Contractor", and <u>Polk County</u> hereinafter called the "County."

**WITNESSETH**, that the Contractor and the County for the considerations stated herein mutually agree as follows:

ARTICLE 1. Statement of Work. The Contractor shall furnish all supervision, technical personnel, labor, materials, machinery, tools, equipment and services, including utility and transportation services, and perform and complete all work required for the construction of the Improvements embraced in the Project; namely, Onalaska WSC Plant 3 E.S.T. - 2021 ARPA-SLFRF, all in strict accordance with the contract documents including all addendum thereto, numbered 1 dated November 27, 2023, all as prepared by GLS acting and in these contract documents preparation, referred to as the "Engineer".

**ARTICLE 2. The Contract Price.** The City will pay the Contractor for the performance of the Contract in current funds, for the total quantities of work performed at the *unit prices* stipulated in the Bid for the several respective items of work completed subject to additions and deductions as provided in Section 00320 hereof.

**ARTICLE 3. The Contract.** The executed contract documents shall consist of the following components:

ARTICLE 4. Performance. Work, in accordance with the Contract dated \_\_\_\_\_\_, shall commence as specified in the Notice to Proceed.

This Agreement, together with other documents enumerated in this ARTICLE 3, which said other documents are as fully a part of the Contract as if hereto attached or herein repeated, forms the Contract between the parties hereto. In the event that any provision in any component part of this Contract conflicts with any provision of any other component part, the provision of the component part first enumerated in this ARTICLE 3 shall govern, except as otherwise specifically stated.
