CHILDRENZ HAVEN

CHILDRENZ HAVEN IS A NON-PROFIT AGENCY THAT COORDINATES THE EFFORTS OF THE POLK COUNTY DISTRICT ATTORNEY'S OFFICE, CPS & LAW ENFORCEMENT WHEN A CHILD ENTERS THE CRIMINAL JUSTICE SYSTEM DUE TO PHYSICAL OR SEXUAL ABUSE OR BY WITNESSING A CRIME.

CHILD WELFARE BOARD (POLK COUNTY CHILD PROTECTIVE SERVICES)

POLK COUNTY CHILD PROTECTIVE SERVICES SUCH AS CHILD CARE, EMPLOYMENT TRAINING, FAMILY SUPPORT, FAMILY VIOLENCE TREATMENT, HEALTH CARE, HOUSING, MENTAL HEALTH CARE, SUBSTANCE ABUSE TREATMENT, AND PUBLIC ASSISTANCE. DONATIONS TO THIS FUND ARE USED TO INCREASE FUNDS FOR HUMAN SERVICES, THEY DO NOT TAKE THE PLACE OF OTHER COUNTY FUNDING.

DONATIONS TO THIS FUND WILL INCREASE THE AMOUNT OF MONEY AVAILABLE TO ASSIST VICTIMS OF CRIME THROUGHOUT TEXAS.
