RE: Request to Replace Current Handheld Radios

Judge Murphy,

The Polk County Sheriff's Office is requesting to replace our current outdated Motorola and ICOM radios. The radios that we currently use are old and many are not working. We are, and have been, experiencing many issues, such as not being able to transmit or hear transmissions to many having broken parts.

The radios that we have sent off for service are coming back either unrepairable or breaking immediately after being placed back on the street. We request to purchase 35 handheld radios (model XL-200P), from L3Harris Technologies. These radios are installed with Bluetooth, WIFI, GPS and Global LTE Modems. The new XL-200P radios will work off of our current system, as well as the 700/800 MHz radio network system, when it is brought online. These features and the installed software is imperative to officer safety and efficiency.

The total price for the 35 handheld radios is \$162,687.00. The entire balance will be paid out of the following:

- \$115,000.00 will be paid out of SB-22.
- \$15,000.00 will be paid from Tobacco Grant.
- \$32,687.00 will be paid from insurance replacement line item.
