Dear Ms. Murphy and Commissioners:

The County received bids for construction of the referenced Water Plant Improvements project benefitting Dallardsville W.S.C. on June 4, 2024. The proposed base bid consists of replacing existing Aerator, Holding Tank, and Related Work. The Additive Alternate Bid consists of replacing the existing Chemical Feed Building.

One bid was received from Duplichain Contractors, in the amount of \$315,600.00 for the Base Bid and \$59,500.00 for the Additive Alternate Bid. A detailed Bid Tabulation is attached.

The construction budget for this project is \$277,500.00, which results in a projected shortfall of \$38,100.00 in construction funds for the Base Bid. We have consulted with Dallardsville W.S.C., and they have agreed to provide funds to cover the difference.

We have previously worked on numerous projects with Duplichain Contractors and believe they are qualified to perform the work. We therefore recommend to award the Base Bid to Duplichain Contractors in the amount of \$315,600.00.

We trust that this information meets your needs at this time. We will be present at your June 11, 2024 Commissioners' Court meeting to discuss any comments or questions you may have.
